Meeting called to order @ 6:30 in the Village quarters at 300 Main Street.

PRESENT: Mayor Caza, Trustees: Palmer, Wood, Johnson and Medak. Amy Wyant (NYPS) and Linda Alescio (Schoharie Promotional). Village DPW Superintendent Bill Shroh, CEO Stannard, OIC Coons, Fire Chief Pierce, and Clerk/Treasurer Leslie Price in attendance.

- A. Amy Wyant MVED NYSERDA, LED streetlight,
 - 1. free technical assistants
 - 2. Offer from provider, National Grid
 - 3. To purchase streetlights NYPA will give a free proposal including entire design phase and examples. Finance not to go against Bond Cap. Arm and Head are owned by the Village, Polls cost between \$4-5 per year/per pole. Pros to owning, right now Village is paying maintenance to National Grid, half the bill is for maintenance. 50-70% savings. Sharon Springs uses NYPA.
 - 4. Clerk/Treasurer will send Amy our lighting bills and insurance costs.

<u>Motion</u> made by Trustee Johnson second by Trustee Palmer unanimously carried to approve a full proposal evaluation of LED lights in the Village.

- B. Community Engagement Program
 - 1. Beekman 1802 Harvest Fest in Sharon Springs has invited the Villages to participate in this event. Linda Alescio and Sherry Carr agreed for Schoharie Promotional to take this on.
- C. CEO Stannard:
 - 1. Parrott House Railing cleanup. Proposes that owner Dean Coughtry spend some time with the Board. Sheriff has contact with Ruth Ann Wilkinson who has keys to the Parrott House.
 - 2. 152 Fort Road has several unregistered vehicles on property. Has been told to get them out of there.
 - 3. 158 Prospect Street, Juanita Krajewski property Write letter advising her to come to the Village meeting. The Village is considering condemning the property. This would be her last opportunity before the Village starts process for condemnation. Attorney Mike Breen should meet with the Board, Lloyd will contact him. Village needs a cost-effective way to handle the property if the Village gets control.
