#### 1) OIC - Brian Rossi

Fire Department is not taking any reservations or fees for garage sale setup. Fire Department is working with local businesses to participate in this event and hopefully promote their business. Fire Department is also planning a formal dinner on the covered bridge hopefully in October. It will be a three-course dinner with music and Fire Department will include childcare services having a movie night with popcorn and care takers.
- d) Fire Department is meeting with Mitchell Architects to address ongoing problems with the new building. They are currently putting together a punch list for discussion.
- e) Credit Cards Doug is requesting that the Fire Department have three cards issued to the Chiefs (Stinson, Pierce and Borst) under the existing account and credit line. The Board agreed to having three credit cards issued to all three Chiefs under the existing account and credit-line.
