A. Safety Training with James Balifore

B. Code Enforcement – Lloyd Stannard

3. Asked the Board to consider eliminating the 10% payment made by employees for their health insurance
4. Mr. Shroh suggested that the Board give 4 weeks vacation after 20 years of service. Currently after 10 years it is 3 weeks vacation and nothing after that. Village Board will consider this suggestion.
